

- Log available of all activity





Harbor Committee 11/18/2012

- Have had 5 complaints about Pleasant Point Harbor
 - Floats hitting boats
 - Unauthorized mooring activity
 - Poor placement of new moorings
- Have asked persons to wait until committee has a chance to comment and direct






Harbor Committee 11/18/2012

- Possible solution is to make a few large rafts
 - Hope for cooperation between the owners
 - Not there, just assign places, manage “uncooperatives”
 - Anchored fore and aft – no swinging
 - Enforce maintenance standards
 - Good floats should not be jeopardized by poorly maintained ones – ordinance requires maintenance
 - Shuffle moorings to make room for rafts and access to them

Harbor Committee 11/18/2012

- Create a float only area on Gay Island side?



- Reallocate float moorings for boats in deeper water

Harbor Committee 11/18/2012

- We have a waiting list for spaces in the harbor
 - Reallocate abandoned moorings
 - Reallocate usurped or unpermitted moorings
- Floats in navigable waters technically need USACE permits also
 - Navigable waters are to “mean high water”
 - Peter Tischbein has given us some latitude
 - Once we have a plan and floats in place I will do the paperwork with USACE for all

Harbor Committee 11/18/2012

- Maneuverability
 - Some moorings placed too close to wharfs
 - If wharf is busy space is very tight
 - When we coral the floats we will ask a couple of mooring owners to move.
 - Brian Fellowes has already contacted me expressed his willingness to work with us for his mooring
 - Suggest he get first pick of spaces
 - Work in progress until we see how much space we can open up

Harbor Committee 11/18/2012

- Approach to harbor
 - New channel buoys obtained
 - Working on getting gear together
 - Damage from near Gay Island in outer harbor
 - Robinson's ramp damaged
 - 2 of 3 Hatch marker moorings gone
 - Poor mooring equipment?
 - Excessive speed using shortest path to harbor?
 - Sea monsters?

- Ordinance Review
 - Jay Clement of US ACE reviewed our ordinance
 - Action suggested by Dave Schmanska of St George
 - 4 page letter of suggestions
 - Fodder for another meeting
